Nonexclusive Publication Agreement

Agreement: We look forward to publishing your article in a forthcoming issue of Journal of Machine Learning Research. **You will retain the copyright to your article since this agreement does not transfer copyright.** However, to enable MIT Press and Journal of Machine Learning Research, Inc. to effect wide dissemination of your work, directly and through arrangements with abstract services, database publishers and others, we require that an author whose work is to appear in Journal of Machine Learning Research give Journal of Machine Learning Research, Inc and MIT Press, Journal of Machine Learning Research's publisher, a nonexclusive license prior to publication of the article in Journal of Machine Learning Research.

Rights Reserved by Author: By retaining the copyright to your article, you are reserving for yourself the following rights among others: 1.) to photocopy the article for use in your own teaching activities, and 2.) to publish the article or permit it to be published by other publishers. **As the licenses we require are nonexclusive, they do not prevent you, the author, from giving or selling similar licenses such as abstracting, indexing, educational photocopying, and electronic reproduction/distribution to other publishers.**

First Publication Rights: You hereby give to Journal of Machine Learning Research and MIT Press the exclusive right of first publication in English. You will ensure that any dissemination of the article authorized by you gives appropriate first publication credit to Journal of Machine Learning Research and MIT Press.

Licenses to MIT Press: You hereby give to MIT Press a nonexclusive license to reproduce, distribute, display and transmit the article in any and all media now known or hereafter discovered. However, we agree not to include the article as a whole, or license others to include it, in any journal other than Journal of Machine Learning Research, or in any book in the nature of an anthology except for (i) anthologies derived in substantial part from Journal of Machine Learning Research and (ii) anthologies (often referred to as "custom textbooks" or "coursepacks") prepared for use in particular courses. In general, the licenses you grant us here are valid only in the English language, but we will have the right to exercise and license foreign language rights in connection with (i) publication of an anthology derived in substantial part from Journal of Machine Learning Research and (ii) quotation of the article in works published in foreign languages. All licenses you grant us are free of any fee or royalty.

The licenses you grant us here may be sublicensed and may be transferred to any subsequent publisher of Journal of Machine Learning Research, and will be valid throughout the world for the entire term of copyright in the article.

Warranties: You warrant that you are the sole author of the Article, and generally that you have a complete and unencumbered right to make the grants you make to us. You also warrant that the Article does not libel anyone, invade anyone's copyright or otherwise violate any statutory or common law right of anyone, and that you have made all reasonable efforts to ensure the accuracy of any factual information contained in the article. You agree to indemnify us against any claim or action alleging facts which, if true, constitute a breach of any of the foregoing warranties.
